

**TERMS AND CONDITIONS**  
**UK PREMIERE FAN AREA DRAW**

**"Wuthering Heights"**

**(DRAW)**

By entering the Draw, you (**You** or **Entrant**) unconditionally accept and agree to comply with these terms and conditions (**Rules**) and agree to be bound by the decisions of Warner Bros. Entertainment UK Limited (**Promoter** or **Warner**) in respect of the interpretation of these Rules and otherwise in relation to the Draw. Entrants who do not comply with the Rules will not be eligible to receive the Pass (as defined below).

Please read the Rules carefully.

**1. Eligibility Requirements**

The Draw is open to individuals who are residents of the United Kingdom and who are eighteen (18) years old and above.

The Draw begins on 12 January 2026 and ends at 11.59PM on 25 January 2026 (**Closing Date**) (together the **Draw Period**).

**Only one Entry per person.**

**2. How to Enter – Winner Selection**

**No purchase is necessary to take part in this Draw.**

Entrants may enter the Draw by:

- (a) Visiting <https://www.warnerbros.co.uk/news/articles/2025/12/23/uk-premiere-wuthering-heights> (**Website**) and clicking on the relevant application form for either:
  - (i) The General Standing Fan Area; or
  - (ii) Accessible Fan Area (Nimbus ID Required); and
- (b) Enter their Full Name, Email Address, Date of Birth and confirmation that they are a UK resident via the Website. If the Entrant is applying for the Accessible Fan Area, such Entrant will also be required to submit their Nimbus ID number.

(an **Entry**).

No other forms of entry will be accepted.

After the conclusion of the Draw Period, the winner(s) of the Draw (**Draw Winners**) will be selected using an automated computer process producing verifiably random results from amongst all valid Entries submitted during the Draw Period.

The Promoter's decision concerning the determination of the Draw Winner(s) and all matters relating to the Draw will be final and binding.

Due to the nature of the Event (as defined below), Promoter is unable to guarantee how many Draw Winners will be selected for this Draw.

**3. The Pass**

The Winners will receive:

A pass for Draw Winner and one optional guest for either the General Standing Fan Area or Accessible Fan Area, as applicable (each a **Fan Area**) for "Wuthering Heights" UK Premiere in London (the **Event**). (the **Pass**)

The Pass is subject to the following terms and conditions:

- a. One (1) x Pass per Draw Winner to the General Standing Fan Area or Accessible Fan Area. The Pass will include details of the location of the Event and time for entry. No entry without a valid Pass. Re-entry is not permitted, unless expressly permitted by Warner.

- b. If the Winner's guest is under 18 (**Minor**), the Winner must remain responsible for their guest throughout the duration of the Event. It is Winner's responsibility to ensure that the Event is appropriate for a Minor.
- c. The Pass permits access to the applicable Fan Area only. This Pass does not provide access to the Event itself, including the red carpet or screening area.
- d. Winners and their guests must adhere to the allocated time slots for entry. If a time slot is missed, Warner may, at its entire discretion, permit late entry.
- e. Travel, accommodation and other expenses are not included.
- f. The Draw Winner and their guest will be subject to health and safety security requirements, including security checks on arrival. All requirements as notified by Warner must be complied with. Failure to comply will result in denied access or removal from the Event and/or Fan Areas.
- g. **Prohibited behaviour:** No illegal or unsafe behaviour; No smoking or vaping; No pets or animals except for guide dogs and hearing dogs (Accessible Fan Area only); No weapons; No access to any area of the event other than areas designated as fan zone areas; No behaviour likely to harass or offend other guests. No use of illegal drugs or consumption of alcohol; No abuse or threats of violence to other attendees or staff; No protest material or oversized banners; No large bags.

#### 4. **Notifying the Draw Winner(s)**

The Draw Winner(s) will be informed by the Promoter via the provided email address within seventy-two hours of the Closing Date. The Draw Winner(s) will be required to confirm acceptance of their Pass by email within timeframe that is specified in the email notification (**Confirmatory Message**). All other requests for information should be responded to within seven (7) days, or such other time frames as specified in correspondence by the Promoter. Should the Draw Winner(s) fail to respond within the allocated time frames, the Pass will be forfeited.

In order to administer the Draw, the Promoter may make use of third party agencies (**Warner Agents**).

#### 5. **Additional Pass Terms**

- 5.1 Delivery timeframes for the Pass will vary and are subject to the processes of the Promoter's third party partners involved in the fulfilment of the Pass. The Pass will be delivered to the email address twenty-four (24) hours before the Event.
- 5.2 The Draw Winner must present valid ID on entry. Acceptable ID is a passport, driving license or Nimbus UK issued Access Card
- 5.3 The Pass is subject to availability. The Promoter takes reasonable care to ensure that the Event is as described in these Rules and on the Website. However, events may occur that make the awarding of the Pass impractical or inappropriate due to unforeseen circumstances or reasons beyond the control of the Promoter. In this situation, the Promoter may vary or amend the Pass to provide a reasonable alternative of equal or higher value as a result of which the Promoter or parties connected to the Promoter shall not be held liable.
- 5.4 No cash, credit or other alternative is available, and the Pass is not transferable.
- 5.5 The Pass does not include anything not mentioned in these Rules.
- 5.6 Any breach of any of these Rules or any unacceptable behavior during the Event that is likely to cause damage, nuisance or injury to any other guest, talent, member of staff or to the Event itself will result in immediate ejection from the Event. Warner has the right to refuse admission or to eject the Draw Winner and their guest from the Fan Area at the Event at its entire discretion.
- 5.7 Should these Rules be breached, Warner reserves the right to restrict access to future Warner events.
- 5.8 If a Draw Winner does not confirm acceptance of their Pass within the required time period, then they will automatically forgo their right to claim the Pass and a runner up will be selected as an

alternative Draw Winner. If such runner up also fails to accept the Pass in the required manner, the next runner up will be selected as an alternative Draw Winner and so on until another Draw Winner is chosen and has duly accepted in accordance with these Rules.

- 5.9 **Consent to Being Filmed and Photographed:** Warner and its authorised third parties may photograph and/or record in the Fan Area and any images and/or recordings may feature the Draw Winner and their guest. All Draw Winners and their guests consent on behalf of themselves or any accompanying Minor (as applicable) to the use of such images and/or recordings by Warner and its affiliates in connection with advertising and promoting of the film that is featured at the Event, without right to further compensation. Draw Winner and their guest acknowledge that the copyright in such images and/or recordings rests with Warner and/or its authorised third party and accordingly you grant Warner and/or its authorised third party all rights in any images and/or recordings of the Draw Winner and their guest including any accompanying Minor.

## 6. **Changes to the Rules**

- 6.1 Subject to applicable law, the Promoter reserves the right to modify the Rules at any time without notice to Entrants. In such circumstances, updated Rules will be uploaded to and published on the Website.
- 6.2 For all that relates to the use of the Website, it is reminded that the Promoter's Privacy Policy <https://www.wbdprivacy.com/policycenter/b2c> and the Promoter's Terms of Use <http://www.warnerbros.co.uk/Home/Info/TermsOfUse> are accessible on or via the Website are applicable. The Rules shall prevail over any inconsistent provision contained in the Terms of Use or the Privacy Policy posted on or via the Website.

## 7. **Eligibility of Entries**

- 7.1 Ineligible or fraudulent Entries are void. All Entrants will be deemed to have authorised the Promoter and Warner Agents to check the completeness and accuracy of the information they supply for purposes of participation. An Entrant who has supplied incomplete, inaccurate or fraudulent information will be automatically disqualified. Any Entry that uses offensive or inappropriate language will automatically be disqualified.
- 7.2 The Promoter and Warner Agents are not responsible for lost, late, or misdirected Entries, for technical, hardware or software failures of any kind, for lost or unavailable network connections, or for failed, incomplete, garbled or delayed computer transmissions or any human error which may occur in the receipt or processing of the Entries.
- 7.3 Proof of entering information on the Website does not constitute proof of delivery or receipt of such information. Promoter is not responsible for the failure of any email or Entry to be received by it on account of technical problems or congestion on the internet or at any website.
- 7.4 Use of computer programs and other automatic means to enter the Draw are prohibited and may result in the disqualification of the Entrant.
- 7.5 The Draw is not open to employees or contractors of the Promoter, Warner Agents, Warner Bros. Entertainment group of companies, including each of their affiliates, subsidiaries, divisions, or Facebook, or Twitter, or any person directly or indirectly involved in the organisation or running of the Draw or their direct family members.
- 7.6 In the event of a dispute regarding the identity of the person submitting an Entry, the Entry will be deemed to be submitted by the person in whose name the e-mail account is registered on the date the Entry is submitted.
- 7.7 Entries become property of the Promoter and will not be returned to Entrants.

## 8. **Use of Personal Data**

- 8.1 In order to participate in the Draw, Warner requires Entrants to provide certain information about themselves on the Website, such as Entrant's name and contact details, that Warner has specified on the Website and which is mandatory in order to participate in the Draw.

- 10.1 The Promoter and Warner Agents do not accept any responsibility for any occurrences resulting from the Entrants' connection to the internet via the Website and/or resulting from participation in the Draw. In particular, the Promoter and Warner Agents do not accept responsibility for any damage or loss caused in any way to Entrants, their computer equipment and/or to data which is stored on any such equipment, or to their personal, professional or commercial activities.
- 10.2 If, for any reason, the Draw is not capable of running as planned, including infection due to computer virus, bugs, tampering, unauthorised intervention, fraud, technical failure, human error or any other causes beyond the control of the Promoter that corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Draw, Warner reserves the right to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify, or suspend the Draw and let the Promoter select an alternative Draw Winner(s) from all eligible Entries received prior to the cancellation or termination of the Draw.
- 10.3 In the event of unforeseen circumstances, the Promoter reserves the right to substitute any or all parts of the Draw. In this event, such a change will be publicised on the Website and any necessary amendments to these conditions will be made.
- 10.4 Entrants agree to the fullest extent allowed by applicable law to release and forever discharge Warner, and its parent corporations, affiliates, subsidiaries, assigns and employees, and any entity or person connected with the Draw from and against any and all claims, demands, losses and liabilities of any nature whatsoever which may now or hereafter arise, including but not limited to any loss of enjoyment, costs, delays or other harm or loss of any nature whatsoever caused by, contributed to, or arising out of or in connection with the Pass and/or attending the Fan Area of the Event.
- 10.5 If any court or competent authority decides that any of the provisions of these Rules are invalid, unlawful or unenforceable to any extent, the Rule will, to that extent only, be severed from the remaining Rules, which will continue to be valid to the fullest extent permitted by law.
- 10.6 Any attempt by an Entrant to deliberately damage the Website or to undermine the legitimate operations of the Draw or use of the Pass may be a violation of criminal and civil laws and should any such attempt be made, the Promoter reserves the right to seek damages from any such person to the fullest extent permitted by law.
- 10.7 The Promoter reserves the right to change, suspend or cancel the Draw without specifying the reasons for its decision and without incurring liability as a result. These Rules will apply to the Draw. The Promoter reserves the right to modify these Rules at any time prior to, during or after the Draw Period.
- 10.8 The Promoter does not exclude any liability for death or personal injury arising as a result of the Draw or in connection with the Pass.
- 10.9 If applicable law does not allow all or any part of the above limitation of liability to apply, the limitations will apply only to the extent permitted by applicable law.
- 10.10 The Draw is governed by the laws of your country of residence. You hereby consent and submit to the exclusive jurisdiction of the courts of your country of residence for any action however so arising out of these Rules.
